

## Cost of Attendance

The non-refundable deposit is due from all attendees regardless of any financial aid award, may be paid online at [www.SCGSAH.org](http://www.SCGSAH.org) or by check or money order on or before Friday, April 19, 2019. Please write the student's name on the memo line of the check or money order. The balance of the tuition, less any financial aid, must be paid in full prior to the respective date below.

### Arts Odyssey Program (2019)

- \$100.00 non-refundable deposit due by Friday, April 19, 2019
- Tuition balance of \$400.00 due by May 24, 2019

### Academy Program (2019)

- \$150.00 non-refundable deposit due by Friday, April 19, 2019
- Tuition balance of \$800.00 due by June 14, 2019

### Summer Dance Program (2019)

- \$150.00 non-refundable deposit due by Friday, April 19, 2019
- Tuition balance of \$1,950.00 due by May 24, 2019

### Residential High School (2019-2020)

- \$150.00 non-refundable deposit due by Friday, April 19, 2019
- The Food Service Payment Plan sheet will provide information on cost and payment plans.

The fees above are required for students attending one of the 2019 Summer Programs and/or the 2019-2020 Residential High School. These fees must be paid in accordance with the dates listed above.
